The DOC will hold citizen meetings or

“Corrections Town Hall Meetings” on a quarterly basis. The meetings will be held via interactive television at sites across the state.

The Department will solicit agenda items for each meeting and work to incorporate the item as appropriate within the time limits of the meeting. All agendas will be posted in advance on the department website.

Agenda topics will focus on department directives, policies and other topics of interest. Participants will sign in at each site. Those who wish to make comments must indicate their intent on the sign-in sheet. Each person will have 2-3 minutes to make comments, depending on the number of people in attendance. All comments will be recorded. The Department will review the comments and post responses on its website after the meeting. The Department will not provide responses to individual comments at the meeting.
